#### 1 Name

This determination is the *Public Service (Subsection 24(1)—Australian National Audit Office Non-SES Employees) Amendment Determination 1/2023.*

# Schedule 1—Amendments

# Australian National Audit Office Subsection 24(1) Non-SES Employees Determination 1/2022

#### 1 Section 9

Repeal the section, substitute:

# 9 Second annual adjustment of salary

- (1) Employees' salaries are adjusted by 3.00%, with effect from 22 April 2023.
- (2) Each adjustment is to be calculated based on the salary immediately before the adjustment under subsection (1).
- (3) The First Aid Allowance, Fire Warden Allowance, Diversity Contact Officer Allowance, Health and Safety Representative Allowance and Restriction Allowance, as described at clause 31.3 to 31.7 of the ANAO Enterprise Agreement 2016-2019, are adjusted by 3% with effect from 22 April 2023.
- (4) Each adjustment of an allowance is to be calculated based on the allowance immediately before the adjustment under subsection (3).
- (5) Schedule 2 has effect.
- (6) This section and Schedule 2 have effect despite section 8 and Schedule 1.

#### 2 Schedule 2

Repeal the Schedule, substitute:

# Schedule 2— Second annual adjustment—Salary from 22 April 2023

# 1 Salary

From 22 April 2023, salary for an employee covered by column 1 of an item of the following table at a pay point described in column 2 of the item is payable at the rate for that pay point (the *new rate*) described in column 3 of the table. This is an adjustment of 3.00% under subsection 9(1) of this determination.
