- Modernise and grow My Health Record utility by requiring inclusion of pathology and diagnostic imaging results, medicines information; complete and timely discharge and transfer of care summaries
- Designed to support the patient, improve health outcomes, and workforce efficiency as well as reduce duplication, wastage, and hospital admissions, and improve health and digital literacy including in vulnerable populations and remote communities, empowering consumers to take greater control of their health journey

• In the medium term drive the National Connected Care Plan to introduce conformance standards supported by regulation designed to improve integration and utility of digital health tools by all healthcare professionals and across care settings to increase the information available in real time to the whole care team

- Continue to transform national infrastructure, building on the new API Gateway and cloud transition that will enable a move away from documents to a contemporary, structured, data-rich health information ecosystem capable of supporting real-time access to information anywhere, anytime – further improving health outcomes, workforce efficiency and system sustainability
- This will also enable the collection of health data to provide patients and their health care providers with rich and informed insights about their health, and flag future direction, enabling collaborative shared investment.
